PRIVACY POLICY

1. GENERAL

The website ("Website") for AdvisorBid Inc. ("AdvisorBid", "Marketplace", "we", or "us") was created to provide transparency for all opportunities throughout the financial services industry with a core focus on recruiting, transitions, buying and selling of advisor books of business (together with the Website, the "Services"). We value the privacy of our Services visitors ("you", "your", or "user"), and in order to protect your personal information, we have implemented the following Privacy Policy with provisions that apply to the collection, retention, and use of data by AdvisorBid, its subsidiaries, and its affiliates. If you have any questions or concerns regarding this statement, you should contact us at contact@advisorbid.com.

Our Privacy Policy discloses the type and nature of information we collect and how we use it, as well as the choices you can make about the way your information is collected and used. We also explain how any requests for personal or personally identifiable information will be used. Finally, we present our security policy, which outlines how your personal information is protected.

2. INFORMATION COLLECTION

By visiting https://AdvisorBid.com, you consent to our collection and use of information as explained in this Privacy Policy, and you agree to be bound by our Terms of Use. Please note that if you choose to recruit advisors, or register a company profile on our website, you may be required to agree to a separate agreement, including, but not limited to, new or additional privacy notices or terms of use. If you have questions or concerns regarding this Privacy Policy, please contact us at contact@advisorbid.com.

Important Information About Procedures for Opening a New Account

When you open an account, we will ask for your legal first name, last name, zip code, legal FINRA registered broker-dealer and/or SEC registered RIA affiliation that will allow us to identify you. If you sign up using your LinkedIn Authentication, then the first step of your identify will be verified. If you do not sign up using your LinkedIn Authentication, then you will need to verify your e-mail address with a unique access link that will be sent to the e-mail that User signed up with from the AdvisorBid Website and/or e-mail server of AdvisorBid.

Required Information to Create User Account

User registration will require you to provide personal data and business data. Personal data and business data typically includes your name, email address, whether a User is a registered financial advisor, business address and Financial Industry Regulatory Authority ("FINRA") registered broker-dealer and/or U.S. Securities and Exchange Commission ("SEC") affiliation(s).

AdvisorBid uses this data to:

- (i) enable you to log in to the Website;
- (ii) establish your ability to maximize opportunities on the Site;
- (iii) determine your credibility to partake in opportunities;
- (iv) verify that you are at least 18 years of age;
- (v) guard against potential fraud;
- (vi) contact you if there is a problem with your account; and
- (vii) maintain regular communications with you as may be necessary to inform you of upcoming opportunities and other company updates.

Traffic Data Collected

We automatically track and collect the following categories of information when you visit our Site: (1) IP addresses; (2) domain servers; (3) types of computers accessing the Site; and (4) types of web browsers used to access the Site (collectively "Traffic Data"). Traffic Data is anonymous information that does not personally identify you but is helpful for marketing purposes or for improving your experience on the Site. We also use "cookies" to customize content specific to your interests, to ensure that you do not see the same advertisement repeatedly, and to store your password so you do not have to reenter it each time you visit the Site.

Personal Information Collected

In order for you to access certain information and services that we offer via the Site, we require you to provide us with certain information that personally identifies you ("Personal Information"). Personal Information includes, but is not limited to, the following categories: (1) Contact Data (such as your name, mailing address, and email address); (2) Financial Data (such as your account or credit card number); (3) Demographic Data (such as your zip code, age, and income); and (4) Business Data (such as company and business information). If you communicate with us by email, post messages to any of our chat groups or forums, or otherwise complete online forms, surveys, or contest entries, any information provided in such communication may be collected as Personal Information.

Non-Personally Identifiable Information

AdvisorBid collects non-personally identifiable information from you regarding your usage of our website ("Non-Personally Identifiable Information"). Non-Personally Identifiable Information may include, without limitation, website pages viewed, articles, presentation and videos viewed, time spent using certain features of the website, demographic data such as server locations, cookies existing on your computer, search criteria used and results, date, time, connection speed, and other information which does not specifically identify you. Regardless of whether you register for an account or submit an application, AdvisorBid collects Non-Personally Identifiable Information using various technologies, including, but not limited to, cookies and server logs.

"Cookies" are small text files placed on your web browser when you visit our Website that store information on your computer, such as your Website preferences. We use cookies when you sign in to keep track of your personal session, including some account identifiers to ensure that you are the only person making changes to your account. We also use cookies to track your activity on the Website as a unique person. For security purposes, all of this information is stored in encrypted form. No personal information about you is stored in this manner. You can set your web browser to inform you when cookies are set, or to prevent cookies from being set altogether. Please note, however, that if you decline to use cookies, you may experience reduced functionality and slower Website response times. In some instances, declining to use our authentication-related cookies may prevent you from using the Website entirely. "Server logs" can be either a single log file or several log files automatically created and maintained by a server of activity performed by the server, which can include information about any transaction you conduct with the server.

AdvisorBid (or our service providers, such as Google Analytics) may also collect web surfing data related to your use of the Website. Such information may include: your Internet Protocol (IP) address, browser type, and internet service provider (ISP); your operating system; which of our web pages you access and how frequently you access them; referral or exit pages; click stream data; and the dates and times that you visit the Website. This data may be collected using cookies, web beacons, page tags or similar tools. As with cookies, the web surfing information is anonymous, "click stream" transactional data that is not associated with any users as individuals.

Web surfing data and similar information may be aggregated for administrative purposes. AdvisorBid may, for example, use this aggregated information in the administration of the Website to improve its usability and to evaluate the success of particular marketing and advertising campaigns, search engine optimization strategies, and other marketing activities. We also use it to help optimize the Website based on the needs of our users.

Advisors in Transition or Selling Book of Business

Producing financial advisors that are looking to transition to a new FINRA registered brokerdealer ("BD") or SEC Registered Investment Adviser ("RIA"), or looking to sell their book of business to another advisor (or adviser) will have their profiles anonymized so no Personally Identifiable Information will NOT been seen by any user or company in which User has not connected to another User or accepted a connection request from such User, and will not be viewable by any company in which user has not clicked "Express Interest" on such Company profile. If an advisor is anonymized, and is already connected to another user or clicked "Express Interest" button on Company profile, that user [or admin User(s) of such Company profile that you clicked "Express Interest" on] will be able to view advisor in transition (or selling book of business) Personal Identifiable Information to connect with, e-mail, and/or call you outside of AdvisorBid website.

AdvisorBid also collects personal information, business information, and book of business breakdown of information from you and your business when you visit the Website. The majority of information is collected during the registration and application processes, as well as when you sign up for an account, transition to a new broker-dealer or RIA, provide payment instructions or send us an email through the AdvisorBid website which may enable us to identify you personally ("Personally Identifiable Information" and collectively with the Non-Personally Identifiable Information, the "Data"). While some items are optional, most are required to verify identity. You may choose to provide additional information during subsequent visits to the Website, but keep in mind that some of this information will be required if you wish to partake in the Services. We may request additional information to help verify your identity or for other purposes. AdvisorBid reserves the right to obtain information about you and or your company from third parties, such as however not limited to FINRA, the SEC, identity verification services, or other third parties at AdvisorBid's discretion for the purposes of, however not limited to, ensuring the accuracy of information. AdvisorBid may use third party data to override your user and or company profile information. If you believe that your information on your User and/or Company profile is not accurate, then please contact us at contact@advisorbid and we'll help you and your company profile update the information on your profile so that the information is as accurate as possible.

LinkedIn Authentication

AdvisorBid has a feature to allow users to use their LinkedIn User name and Password as an authentication token to sign up to the Marketplace more quickly. AdvisorBid only stores the encrypted token produced by LinkedIn and will never be in possession of Users actual password for LinkedIn.

Google API

AdvisorBid uses location and zip code provided by Users to calculate User's latitude and longitude using Google API to help Users more effectively identify opportunities. AdvisorBid collects data from many resources to determine general location of each User, however AdvisorBid does not guarantee or ensure the accuracy of such locations.

Stripe API

AdvisorBid uses Stripe API for payment processing for marketing purposes, such as AdvisorBid's Weekly Snapshot or advertising throughout AdvisorBid Website, as those features or advertising opportunities become available.

Miscellaneous

AdvisorBid may also collect and store information, which could include Non-Personally Identifiable Information or Personally Identifiable Information, locally on your computer or device using mechanisms such as browser web storage or application data caches. We may also have access to your Personally Identifiable Information when you log into our website through certain third party social networking services, including Facebook, LinkedIn, Twitter and Internet Chat ("Third Party Services"). We encourage you to carefully review the privacy policies of any Third Party Services from which you access our website.

This Privacy Policy does not cover the collection of information by cookies or other methods by third parties, such as our business partners. We do not control how such third parties collect information or by what means as such third parties may use their own cookies to collect information about you.

3. HOW AND WHEN YOUR INFORMATION IS SHARED WITH OTHER PARTIES

AdvisorBid does not sell or rent personal information for marketing purposes about its users or company profiles that you've uploaded or shared, unless otherwise stated in this Privacy Policy.

Usage & Sharing of Data

AdvisorBid will use information you provide consistent with this Privacy Policy. AdvisorBid will use information you provide to us, including Non-Personally Identifiable Information or Personally Identifiable Information, to better serve you and enhance your experience with the AdvisorBid website, among other things. This may include having to modify or copy such information, such as images or textual or narrative content you provide, in order to provide you with a seamless and enjoyable experience.

AdvisorBid will use Non-Personally Identifiable Information and Personally Identifiable Information that you've uploaded or shared:

Your Non-Personally Identifiable Information and Personally Identifiable Information is stored on secure servers that are not accessible by third parties. We provide you

with the capability to transmit you Personal Information via secured and encrypted channels if you use a similarly equipped web browser.

If you provide Data for a certain reason, we may use the Data in connection with the reason for which it was provided. For instance, if you contact us by email, we will use the Data you provide to answer your question or resolve your problem. AdvisorBid may also use your Data and other personally non-identifiable information collected through our website to help us improve the content and functionality of our website, to better understand our users and to improve our services. As user of our services we will send you administrative communications that are reasonably necessary to our services, such as billing or service notifications.

Notifications and Communications from Our Website
